Harper's Playground contributed funds to the City of Portland as well as the Parks Bureau to provide assistance building a park in NW Portland (Couch Park). The funds were provided to ensure that the park was designed and built to allow people of all abilities to use the park. specifically, the design was intended to allow those experiencing a disability and/or requiring wheels for mobility could use and enjoy the park. Harper's Playground worked closely with the community and Parks Bureau to ensure the design of the park met the goals of Harper's Playgrounnds mission.

Harpers Playground is committed to keeping the original Harpers Playground park in NE Portland in great shape for all to enjoy. Harpers Playground hosts several clean up days throughout the year where volunteers learn about the park while doing general cleanup which includes gardening. The gardening allows Harpers Playground to be pesticide free. In fiscal 2017 a new tactile braille map was added to the park which is not only functional but also a beautiful bronze art piece.

Throughout the year Harpers Playground Executive Director spends a significant amount of time educating other advocacy organizations interested in implementing our model in their communities on the design elements required for full inclusion. By giving others the tools and knowledge to build inclusive playgrounds Harpers Playground can have a much broader reach than building one playground at a time. Harpers Playground will focus on this in the coming years by developing resources such as a How To Guide and hosting events to further educate others in inclusive design.
