Direct partnership model support. We completed our third inclusive playground project in the Portland Metro Region. Our support for this Couch Park Playground helped ensure that this vital asset was inclusive and natural. This particular project was important as it is located adjacent to a school and is in an overaly urban area devoid of green spaces. We leveraged our financial contribution for greater impact against an existing Portland Parks & Recreation Bond passed in 2014 and in partnership with a local community group called "Friends of Couch Playground." The Playground has since been recognized for its design excellence by the Oregon Recreation & Parks Association.

Indirect consultation & open-source tool development. We completed a "How-To" book that we began to share far and wide through our website and also shared digitally to those who contact us seeking guidance. This model of information sharing was successful in motivation and guiding several projects around the world.

Playground maintenance and programming. We gather community support for the upkeep of our flagship playground. These volunteer hours help ensure that the playground is navigable by our target population of people who use wheels to get around. These events also ensure the longevity of this valuable community asset. We also held regular guided-tours for communities interested in duplicating our model where they are. These tours are the best way to guarantee our model is successfully replicated.
